Places are identified for inclusion in the 'Other Metro Set-Aside' using the US Census Bureau 'Urbanized Areas' designation. Urbanized Areas are defined by the US Census Bureau as densely settled territories that contain 50,000 people or more. All places (incorporated local governments and Census Designated Places) within the Urbanized Area territories are considered part of that Urbanized Area. For more information about how the US Census Bureau designates Urbanized Areas see FR Doc No: 2012-6903 and FR Doc No: 2011-21647. For the purposes of the Other Metro Set-Aside, the Illinois Housing Development Authority excludes all Urbanized Areas that are otherwise included in the City of Chicago Set-Aside and the Chicago Metro Set-Aside. The Authority does include places that are part of Urbanized Areas that cross state boundaries (e.g.: South Beloit, East Cape Girardeau, etc.).
